BUTTS COUNTY YARD SALE APPLICATION

Individuals interested in operating a yard sale within the county limits of Butts County, must obtain a permit for such. Yard/Garage/Estate sales must be in compliance with ordinances if any, also rules that may apply enforced by the Butts County Planning and Development.

- 1) No Person shall hold a yard/garage/estate sale within Butts County without first obtaining a permit and a current proof that all County taxes have been paid.
- 2) Permit must be posted in a conspicuous place during time and place of sale.
- 3) Proof of permission. (signed & dated letter by property owner).
- 4) Sales must be confined on applicable property and restricted from right-of-way and streets.
- 5) **No more than three (3) yard sales by the same property owner and or applicant are to be held in a twelve (12) month period on the same premises or any other premises. The duration of any yard/garage/estate sale shall not exceed three (3) consecutive days.**
- 6) One (1) sign is permitted, not to exceed two (2) square ft. upon the property where sale is taking place. All other signs without property owner permission, proper sign permits or failure to abide by Butts County Sign Ordinance on premises or other location are prohibited.

PLEASE NOTE: VIOLATION OF ANY PART OF YARD/GARAGE/ESTATE SALE ORDINANCE SHALL BE SUBJECT TO FUTRTHER ACTION.

As a courtesy, the Butts County Planning & Development, we ask that there be a three (3) day notice of sales to avoid and clear any conflict that may delay or prohibit your operation.
